#### **PRECAUTIONS**

Operator protection: Engineering control of operator exposure must be used where reasonably practicable in addition to the following personal protective equipment: Wear suitable protective clothing (coveralls), gloves and eye/face protection (faceshield) when handling the concentrate. Avoid contact with skin and eyes. Avoid breathing spray. Wash all protective clothing thoroughly after use, especially the inside of gloves. Wash hands and exposed skin before eating meals and drinking after work.

**Storage and Disposal:** Keep in original container, tightly closed, in a safe place. Keep away from food, drink and animal feeding stuffs. Wash out container thoroughly and dispose of safely. Do not re-use container for any other purpose. When using do not eat, drink or smoke.

**Environmental protection:** Do not contaminate surface waters and ditches with chemical or used container.

#### FIRST AID

IF ON SKIN: Wash with plenty of water. If skin irritation or rash occurs: Get medical advice/attention. IF IN EYES: Rinse cautiously with water for several minutes. #### **GENERAL INFORMATION**

Kantor is a unique adjuvant designed to improve the performance of crop protection products under adverse conditions. Kantor buffers spray water for optimal performance, improves tank-mix compatibility, reduces spray drift, and enhances product effectiveness by increasing coverage, adhesion, and penetration across plant surfaces. Kantor adjuvant assists the efficiency and efficacy of herbicides, fungicides, insecticides, plant growth regulators and foliar nutrition products.

#### IMPORTANT INFORMATION

Maximum rate of use: 1.0% of the final spray solution (e.g. 2 litres of product in 200 litres of water per hectare).

#### **DIRECTIONS FOR USE**

**Kantor** should be used at an appropriate rate for the capacity of the spray tank to give a 0.15% dilution of the final water volume. For example:

Water Volume	Required Quantity of Kantor at 0.15%
100 litres	150ml
200 litres	300ml

#### MIXING

#### Note: Always add Kantor first to the spray tank after water

Half fill the spray tank with clean water and commence agitation. Add the recommended quantity of **Kantor**. Then add the recommended quantity of pesticide and the remaining balance of water whilst maintaining agitation throughout. If foaming occurs, add the required quantity of anti-foaming agent to remove foam.

#### Protect from frost.
