Tanker/Vehicle Accident		Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111								
Spill or leak	glove dowr	Keep all bystanders away. Wear goggles, respirator, full length chemical resistant overalls (buttoned to neck and wrist), gloves and boots. Sweep up spilled material with inert material and place in sealable container for disposal. Wash down affected area with water plus detergent. Large spills/leaks: Call emergency services 0800 CHEMCALL (0800 243 622). Seek advice from local authority regarding disposal.								
Fire		Call the Fire Service : Dial 111 . Wear PVC protective clothing and breathing apparatus. Extinguish fires with foam, dry chemical or CO ₂ . During a fire toxic fumes may be released. Contain run-off. Keep non-involved persons away.

If Swallowed		DO NOT induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately. Do not give anything by mouth to an unconscious person.								
If in Eyes	Hold	Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes. Get medical attention.								
lf on Skin	cloth	If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water and soap. Wash clothing before reuse. Destroy contaminated shoes and other contaminated leather articles such as belts and watchbands.								
lf Inhaled		Remove patient to fresh air. If not breathing, give artificial respiration, preferably mouth-to-nose. Get medical attention if symptoms develop.
