EMERGENCY PROCEDURES 24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 243 622 IF THIS HAPPENS DO THIS Tanker/Vehicle Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Accident Call the emergency services: Dial 111 Spill or leak Keep all bystanders away. Wear goggles, chemical resistant gloves and respiratory protection if insufficient ventilation. Absorb spills with inert material and place in waste containers. Wash area with water and absorb with further inert material. Dispose of contained wastes in accordance with the requirements of Local Authorities. Fire Call the Fire Service: Dial 111. Wear full protective clothing and self-contained breathing apparatus. **FIRST AID** If Swallowed Immediately call a POISON CENTER or doctor/physician. Rinse mouth. DO NOT induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately. Do not give anything by mouth to an unconscious person. If in Eyes Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes. Get medical attention. If on Skin Take off contaminated clothing. Wash skin with plenty of soap and water. Do not scrub skin. Call a Poison Centre or doctor for treatment advice if irritation develops. Wash contaminated clothing before reuse. If Inhaled Remove patient to fresh air. If not breathing, give artificial respiration, preferably mouth-to-nose. Get medical attention if
